These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications. Participants should retain a copy for their information.

- 2. Who is eligible:** Employees of any company that holds an active contract for a Cycle Benefit Scheme managed via The Promoter that have completed an application for the Cycle Benefit Scheme during the Promotion Period, and subsequently received their Letter of Collection and passed their 14-day cooling-off period within 15 working days of the Promotion Period ending.
